Position Paper for Public Consultation

Workforce development takes centre stage for Ireland as businesses, particularly Small and Medium Enterprises (SMEs), face a host of challenges.

Developing a strong, digitally resilient, and sustainable talent pipeline will be crucial for businesses of all sizes to leverage the economic opportunities presented by high-tech innovation, digitalisation, the green transition whilst navigating inflationary pressures and evolving geopolitical dynamics.

### Skillnet Ireland Introduction

Skillnet Ireland is the national agency responsible for spearheading workforce development for the enterprise sector on behalf of the Government of Ireland. Our deep roots with enterprise allow us to respond to policy and skills challenges in a proactive and agile manner.

In partnership with industry, we offer demand-led upskilling programmes that are innovative and flexible, to enhance the productivity, competitiveness and sustainability of the Irish economy.

Skillnet Ireland prepares businesses and workers for the future of work through enterprise-led workforce development. We have two main programmes.

### Skillnet Business Networks

Skillnet Ireland's 69 Skillnet Business Networks across all sectors and regions of the economy are the flagship of Skillnet Ireland's offering.

Skillnet Ireland's decentralised model generates highly specialised upskilling and training supports for businesses that align with labour market needs. The Skillnet Business Network Model has received international recognition as a best practice approach from the OECD, the EU Commission and the ILO, amongst others.

Skillnet Ireland supports talent development within sectors right across the economy and supports national policy imperatives. Skillnet Business Networks adopt an enterprise-led approach to learning where groups of enterprises can develop strategic solutions to their joint workforce development needs and improve the adaptability and long-term employability of workers, driving increased uptake in lifelong learning.

Through the development of innovative upskilling programmes and flexible methodologies, Skillnet Business Networks deliver effective and user-friendly upskilling solutions for companies and workers.

### Skillnet Ireland's National Talent Initiatives

During the period of the last Statement of Strategy, Skillnet Ireland expanded its offering to a number of national talent initiatives, developed in partnership with industry. These initiatives support upskilling and business development across priority areas including SME competitiveness, innovation, offshore wind, modern methods of construction (MMC) and climate readiness.

## Statement of Strategy Consultation 2026–2028

Skillnet Ireland is seeking your views on three thematic areas that will be fundamental to the success of the new Statement of Strategy 2026-2028:

### Strengthening Enterprise Competitiveness

Skills and upskilling are central to enterprise competitiveness enabling businesses to innovate, improve productivity, and respond effectively to emerging opportunities and disruptions. As the Irish economy continues to evolve, skills needs are projected to become increasingly specialised in areas such as, advanced manufacturing, bioprocessing, big data analytics, robotics, and the green transition. Job roles will be redefined, and new roles will emerge that require new and different skillsets. Today's workforces have higher expectations from employers when it comes to career development and are actively seeking access to upskilling programmes, mentorship, and career growth opportunities. To maintain a competitive edge, businesses of all sizes must adapt to these challenges by investing in workforce development and lifelong learning, to reinforce Ireland's position as a leading destination for talent.

### Accelerating Digitalisation and Al

The Harnessing Digital Strategy sets a goal for Ireland to become a digital leader both within Europe, and globally. The framework includes the aim of 90% of SMEs achieving basic digital intensity and 75% utilising Artificial Intelligence, cloud computing and big data by 2030. Skillnet Ireland has a series of targeted initiatives to support the acceleration of digital transformation with 14,000 workers benefiting from Skillnet Ireland supported digital skills programmes annually. With a two-pronged focus on developing specialised talent for new or emerging technologies such as AI, cybersecurity and enabling digital transformation within the SME sector, Skillnet Ireland is committed to building a highly skilled pipeline of employees equipped with AI and advanced digital skills. This is critical to achieving these goals and securing Ireland's reputation as a high-performing economy and a hub of innovation for emerging technologies.

### Climate Change and Sustainability

One of the key factors for Ireland to halve carbon emissions by 2030 and achieve carbon neutrality by 2050, is access to the right skills and talent. For Irish businesses, the climate transition is both an opportunity and a challenge, requiring significant investment in workforce upskilling. Addressing the talent challenges associated with climate change has been a focus for Skillnet Ireland for some years. Over 7,000 employees benefit from climate and sustainability upskilling programmes delivered by Skillnet Ireland covering energy management, offshore wind, water stewardship, biodiversity management, sustainable finance and ESG (Environmental, Social, and Governance) reporting, all aimed at helping businesses tackle decarbonisation.

Skillnet Ireland has commenced a wide-ranging strategy consultation process with its industry partners and stakeholder groups including enterprise, Government Departments and agencies, education sector and representative groups to help set out a clear vision for future growth, transformation and development of the agency.
